WHERE: Back Parking Lot of ALL STAR LEGACY (Dulles Location)

BOOTH SIZE: 10' x 10'

COST: \$50.00

EVENT TIME: 1:00-5:00p.m. **VENDOR MUST BE SET UP BY 12:00 P.M. and CAN NOT TEAR DOWN UNTIL EVENT AREA HAS CLEARED!**

APPLICATION DEADLINE: Friday, October 10, 2009

IMPORTANT INFORMATION:

- All applications are considered on a first-come, first-serve basis.
- In the event the Pep Rally/Vendor Day is cancelled due to weather and a rain date is provided and you cannot attend the rain date, no monies will be refunded. If, however, the event is cancelled your money will be refunded within 30 days.
- All spaces and set-up times will be assigned! **Please note booth size!**
- Vendors must stay in their assigned space! Vendors shall not sublet any part of their space. Vendors are responsible for clean up of their area including any trash.
- Vendors must stay for the entire duration of the event and may not leave the booth unattended during the show hours, except for short periods.
- Vendors must provide their own display items, tables and chairs.
- **Vendors must provide Spirit Club an item (\$10 Value) to raffle during the Pep Rally.**
- All items for sale must be **legal goods**. No fraudulent or counterfeit items that violate copyright laws will be permitted!
- No vehicles are permitted in the event area, except during initial set-up time to deliver items!
- Electricity and water are NOT provided.
- Event organizers reserve the right to limit the number of vendors per category, but exclusivity of items is NOT guaranteed.
- Spirit Club Corp. will not accept responsibility for lost, stolen or damaged items.
